### The School

We will:

- Support my/our child in reading and homework;
- Support the school's policies and guidelines on behaviour;

- Use social networking sites with responsibility by:
  - (i) raising any issues using official school channels rather than posting them online;
  - (ii) not posting malicious or fictitious comments about any member of the school community.

### The pupil

I will :

- Come to school every day, on time and ready to learn;
- Bring everything I need for the day;
- Wear my school uniform with pride;
- Work hard and listen carefully;
- Be polite and helpful to everyone in school and follow the school rules;
- Talk at home about what I learn at school;
- Do my class work and homework as best as I can.

## **Appendix 1**

Section 16 of the Wellsway Multi Academy Trust's 'Attendance and Punctuality' policy outlines the fines that may be payable if parents take their children out of school during term time. **You may be charged if you take your child out of school and it is not authorised:**

### **16. Penalty Notices (see Appendix 1)**

*Accumulated unauthorised absences may result in a Penalty Notice being issued by Bath and North-East Somerset council. These fines are £60 (per parent, per student) if paid within 28 days or £120 if paid between 29 and 42 days. If the penalty is not paid and the notice is not withdrawn the parent/carer will be prosecuted in the Magistrates Court for the offence of failing to ensure their child's regular attendance at school.*

*Penalty Notices will only be issued after a series of strategies have been tried and no improvement seen. The decision to issue a Penalty Notice is taken by the Local Authority following a request from the school. Copies of paperwork sent by the LA to parents/carers are also issued to the school and kept on pupil/student files.*
